#### ITEM VII. REPORTS

- a. Executive Director's Report
  - \*Executive Director Raymond Concho, Jr. provided the Board with a written report (attached). Further discussion took place in regards to the Executive Director's report on the Mortgage Code and the Drug Elimination Program financial closeout.
  - \*The Acoma Tribal Courts has asked PAHA to try to compromise with homebuyers/homeowners prior to eviction proceedings.
  - \*PAHA was acknowledged by HIP the capability of conducting environmental reviews.
  - \*An assessment was requested by Commissioner Vallo on the role & responsibility of the Board. A draft annual report is in the process of being developed, the Board would report to the Tribal Administration and Council. Executive Director Concho is also in the process of preparing the Annual Performance Report that goes to HUD. It was suggested that the Board also advocate to the Tribal Administration and Council to help change the funding methodology of HUD to supplement or match funding for HIP programs
- b. Drug Elimination Report Rose Leon, Director



\*DEP Director Rose Leon provided the Board with a written report (attached). Further discussion took place in regards to the report: the concern was on the liability of the childcare services that the program is providing. Ms. Leon informed the Board that the two staff are certified/trained for the recreational part of the program, but would check into further training. A funding profile and corrective action plan (attached) on the DEP Program was provided to the Board for review. After a lengthy discussion, a directive was given to Executive Director Concho to put together the required amendment to the FY98 Indian Housing Plan for HUD's approval to cover the expenditures of the DEP Program that the IHBG funds may not cover.

c. NAIHC 6<sup>th</sup> Annual Legislative Conference Travel Report
Chairman Harold Felipe & Vice Chairman Tim Chavez provided a verbal report on their
travel to NAIHC's 6<sup>th</sup> Annual Legislative Conference held in Washington, DC. The
conference went well. Governor Lloyd Tortalita also attended the conference and
provided information on the tribe's housing needs to the Representatives at the Capitol.
Chairman Felipe commended Governor Tortalita on a job well done. Vice Chairman
Chavez commended the PAHA staff for putting together the packets of information that
was shared with the Congressional delegates. It was suggested that PAHA continue to
pursue efforts of NAIHC to influence policy changes to HUD programs for Acoma.
Another recommendation was to include trip reports in the newsletter.

\*Motion to accept the Executive Director's report of March 14, 2000 was made by Commissioner Vallo, seconded by Commissioner Johnson, motion carries.

#### ITEM IX. NEW BUSINESS

- a. Presentation of Contracts for 61 Housing Unit Projects and Proposed Subsequent Interviews with Board of Commission
  - \*Development Specialist Derek Valdo provided the Board with the tally on three contractors who were selected on possibly conducting business with PAHA. The next recommendation is the visit the site developments of the three construction companies and talk with them. The three companies selected include: Richey Construction Company, Collatz Incorporated & Evans Southwest Inc. A concern by Commissioner Vallo is the infrastructure in building these 61 units. Mr. Valdo and Mr. Concho provided the Board with information that funding resources are currently being sought in order to provide the infrastructure to these units.
- b. Indirect Cost Service Agreement
   \*Executive Director Concho provided the Board with a final Indirect Cost Service
   Agreement between PAHA and the Pueblo of Acoma Central Accounting Department.
   Motion to accept the agreement between the two (2) entities was made by Commissioner
   Vallo, seconded by Vice Chairman Chavez, motion carries.
- c. Proposed Policy Amendments: MEPA & Payment Deferment

  \*Proposed policy amendments to the MEPA & Payment Deferment plans were
  presented to the Board. After further discussion, the HOC's were directed to reemphasize to homebuyers/homeowners that MEPA usage would only be considered if
  there was a TAR balance or a delinquent account on a one-time request. Further
  discussions and/or comments to be considered after the Homeownership Week activities
  are done.
- d. Drug Elimination Program Status \*Friday, March 17, 2000 would be the last day of employment with DEP for the DEP staff. They have already been placed in different areas of the pueblo. The DEP program's financial status is currently being corrected by the Acoma Central Accounting Department. A spending freeze was made by the Central Accounting Department pending financial reports from PAHA to the Accounting Department. Access to the LOCCS financial system to drawdown funds for the DEP program were not being authorized due to the lack of financial reports. An estimated total of \$196,000 may be

returned to HUD/DEP programs from PAHA. A corrective action plan is currently being worked on by Executive Director Concho and will be presented to the Board. The Board directed Executive Director Concho that the corrective action plan on the DEP program will be required in 2-3 weeks. Warnings have been sent to PAHA from HDS on the lack of the financial reports. A directive from Governor Tortalita was a meeting with PAHA Accountant Pat Alonzo on Friday, 3/17/00 at 1 PM regarding the financial status of the DEP Program.

\* After further discussion, a directive was made by the Board that Mr. Concho send a representative to participate on his behalf to the eight meetings he had identified he would be attending. The Board felt that Mr. Concho's commitment to PAHA was a priority, especially in helping to close out the DEP Program and providing a corrective action plan.
