Call to Order Item I The meeting was called to Order at 6:50pm by Tim Chavez Jr., Chairman. The meeting was conducted in the PAHA Conference Room.

Invocation Item II

Approve Agenda Item IV

The Regular Meeting Agenda was reviewed and no revisions were made. A Motion to Approve was made by Vice-Chairman Johnson; it was seconded and the Motion carried.

Regular Meeting Minutes for 9/18/2001 were reviewed. Grammatical and wording revisions were noted for revision. A Motion to Approve was made by Commissioner Valle: it was seconded and the Motion carried.

Item VII Reports

1. Financial Report, Jack Rodgers, Central Accounting Office. This report was tabled until the next BOC Regular Meeting.

2. Executive Director's Report, Raymond Concho Jr., Executive Director, PAHA. A copy of the Executive Director's Report was included in the BOC meeting packets. The major highlights of the Report are:

 Proposals for a community-wide housing inventory have been submitted and are in the process of being reviewed and ranked.

 The Pueblo of Acoma Mortgage Code is under review by HUD for acceptance. Funding from the PMI Partnership agreement has been tabled from further action by the BOC until the HUD review is complete.

 The PAHA FY 2001 Indian Housing Plan was resubmitted on September 12, 2001 and a review by HUD is pending.

A Motion to Accept the Executive Director's Report was made by Secretary Mousseau; it was seconded and the Motion carried.

- 3. Traditional and Modernization Report, Floyd Tortalita, Development Specialist. A copy of the Traditional and Modernization Report was included in the BOC meeting packets. The highlights of the report are:
- The Water Conservation Project is nearing completion.
- The rehabilitation of (1) vacant housing unit in the Skyline area has been initiated and the completion date has been set at 45 days.
- The construction of the Traditional Model Homes is continuing. The completion date may be extended until June 2002.
- The Mechanical Rehabilitation and Training Program contract with All Temperature Systems is being finalized. The Program will be supervised by Leo Alderette.
- 4. 61 Unit Housing Project Report, Mark Thompson, Project Manager. This report was tabled until the next BOC Regular Meeting.

Old Business item VIII

A Resolution was introduced (Resolution No. PAHA-100901-01); Recommendation to the Pueblo of Acoma Tribal Council to Appoint (2) new Board of Commissioners. There was no action taken upon the Resolution. Interviews for the (2) Commission seats were scheduled for 10/22/2001 at the PAHA Conference Room. The results of the interviews will be noted into the Minutes for the 11/14/2001 BOC Regular Meeting.

Item IX New Business

1. Quit Claim Deeds. Quit Claim Deed documents (2) were presented to the BOC for signatures and attesting. Chairman Chavez and Secretary Mousseau signed as officers of the BOC with an Official PAHA BOC Seal affixed to the Deeds. The Deeds were to be forwarded to HUD for acknowledgement.
